



**RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

READ CAREFULLY BEFORE SIGNING  
MARTIAL ARTS TRAINING CAN BE DANGEROUS AND CAN  
INVOLVE SUBSTANTIAL RISK OF SERIOUS BODILY INJURY AND/OR HARM!

In consideration of being permitted to participate in any way in Martial Arts activities, training, programs and/or classes indicated below and/or being permitted to enter for any purpose any restricted area (here in defined as any area where in admittance to the general public is prohibited), the parent(s) and/or legal guardian(s) of the minor participant named below (the "Minor Participant") or, I (the "Adult Participant") agree that:

1. The parent(s) and/or legal guardian(s) of the Minor Participant will either: (a) instruct the Minor Participant to; or (b) themselves, inspect the facilities and equipment to be used, prior to participating in the below Martial Arts activity or event, and if he or she believes anything is unsafe, the Minor Participant or the parent(s) and/or legal guardian(s) of the Minor Participant should immediately advise the officials of such condition and refuse to participate. I understand and agree that, if at any time, I feel anything to be UNSAFE; I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.

2. I/We fully understand and acknowledge that:  
a. There are risks and dangers associated with participation in martial arts events and activities, which could result in bodily injury partial and/or total disability, paralysis and death.  
b. The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.  
c. These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including, but not limited to RONIN MARTIAL ARTS ACADEMY, their officers, agents and/or employees, other participants, owners and lessor of premises used for the activity, and the other "Releasees" named below.  
d. There may be other risks not known to us or that are not reasonably foreseeable at this time.

3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of RONIN MARTIAL ARTS ACADEMY or the other Releases named below.

4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, RONIN MARTIAL ARTS ACADEMY including its shareholders, instructors, sub contractors, directors, owners, employees, managers, promoters, the lessees of the premises used to conduct the martial arts event(s), class(es) or program(s), premises and event inspectors, underwriters, consultants and others who give recommendations, directions or instructions to engage in risk evaluation or loss control activities regarding the martial arts facility or events held at such facility and each of them, their directors, officers, agents, employees (all of the above parties are for the purpose of this document also referred to as "Releasees" from all liability to the undersigned) my/our personal representatives, assigns, executors, heirs and next to kin for any and all claims, demands, losses or damages and any claims or demands therefore on account of any injury, including but not limited to the death of the participant or damage to property, arising out of or relating to the event(s) caused alleged to be caused in whole or in part by the negligence of the Releasee or otherwise.

5. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

6. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.

7. On behalf of the Minor Participant and/or, individually, as an Adult Participant, the undersigned partner(s) of the Adult Participant and/or legal guardian(s) for the Minor Participant executes this Waiver and Release. If, despite the release, the Adult Participant, the legal guardian of the Minor Participant or any other third party related to an Adult or Minor Participant makes a claim against any of the Releasees, the Adult Participant and/or parents(s) and/or legal guardian(s) of the Minor Participant will reimburse the Releasee for any money which they have paid to the participant, or on his behalf, and hold them harmless.

8. I/WE hereby certify that I, the Adult Participant and/or the Minor Participant is in good health and has no mental or physical condition or symptoms that could interfere with my/our/his or her safety or the safety of others while participating in any activity, using any equipment or facilities of RONIN MARTIAL ARTS ACADEMY. I/WE understand and agree that I/WE alone am/are responsible to determine whether I, and/or, the Minor Participant am physically and mentally fit to participate, perform or utilize the activities, programs, equipment or facilities made available By RONIN MARTIAL ARTS ACADEMY and that I/WE am NOT relying on any advice from RONIN MARTIAL ARTS ACADEMY in this regard. To the extent I/WE have any questions or need any information about the Adult Participant and/or Minor Participant's physical or mental condition or limitations, I/WE agree to seek professional advice from a qualified physician.

9. I/We acknowledge that any photos or videos taken of me or my child during RONIN MARTIAL ARTS ACADEMY classes, courses, workshops or other events may be used to promote RONIN MARTIAL ARTS ACADEMY.

10. I/We agree to pay the membership fees required from each RONIN MARTIAL ARTS ACADEMY student in the amount set from time to time and which is disclosed by RONIN MARTIAL ARTS ACADEMY.

11. I/WE affirm that I/WE freely and voluntarily signed this agreement without inducement, assurance or guarantee being made or that I/WE are the parent(s) or legal guardian(s) of the Minor Participant for whom I/WE are giving up legal rights and/or remedies which may be available to the Minor Participant for the ordinary negligence of RONIN MARTIAL ARTS ACADEMY or the other Releasees.

12. By signing this form I/WE agree to comply, or, to ensure as far as possible that the Minor Participant will comply with all RONIN MARTIAL ARTS ACADEMY rules and regulations.

13. I/WE acknowledge the information I/WE has/have provided is true and correct

I/WE HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS AND INTEND MY/OUR SIGNATURE(S) TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
